- Set-Up Fees: 50 € (deductible from registration fees).
- Registration fees are set at 400 €. Payment must be made within one month after receipt (by email) of a letter of acceptance and invoice, to be paid to the University of Poitiers. Registration will only be definitively validated and registered after payment of the invoice.
- No refunds will be issued after May 1st.
- Registration deadline: March 1st, 2013.
